
Student Support Services

 - Special education, Counseling services, METCO, health services, English
 Language Education, Home Hospital Tutoring, and educational stability for students in foster care or homeless situations
- Student Support Service staff work closely with general education teachers and school leaders to support classroom and school-wide inclusive practices that promote the academic, social-emotional, and mental and behavioral growth of all students


FY25 Student Support Services Budget Drivers

- Ensure a continuum of Special Education Programs and Services Prek-PG to meet the individual needs of students with disabilities
 - Increased enrollment in the Elementary Intensive Learning Center
 - Related service needs including Deaf/Hard of Hearing services and counseling
 - Teaching Assistants previously Grant funded
 - Out of District Cost Increases
- Ensure compliance with English Language Education Requirements
 - Corrective Action determined by state audit to increase staffing and support for English Language Learner students


Special Education Student Enrollment






English Learner Student Enrollment

DESE Review and Corrective Action

The purpose of the Tiered Focused Monitoring Review is to monitor compliance with regulatory requirements focusing on English Learner Education (ELE).

12 ELE criteria that target implementation of the requirements related to ELE programs (e.g. Initial Identification of ELs, EL Programs and Services, Exit and Readiness, Parent Involvement)

Areas in Need of Correction Action

- The district lacks the ESL staffing capacity to effectively provide an effective ELE program
- The district does not have an ESL curriculum that is integral to an effective ELE program
- Translations and interpretations are not always provided for parents

Continuous Improvement Plan (CIMP) in progress to address these areas

- Budget requests to meet staffing and language assistance needs (interpreter phone line)
- Work with consultant around curriculum alignment and enhancement (partially grant funded)
