Chair Spangler introduced this item. He welcomed Diane Simmons, Director of Strategic Planning and Community Engagement, and invited her to present the 2022 District Survey Results.

Ms. Simmons reviewed the results of the 2022 district survey with the School Committee. She stated that 1,847 parents of students in grades Pre-K to 12 responded to the survey as well as 3,426 students and 616 staff. She stated that the survey is an important engagement tool because it helps the school department respond to feedback from students, parents, and staff. She added that the perspective from all three of these stakeholder groups is critical to understanding data. She also added that the survey is an indicator of where the district has strength and where there are areas that need attention.

Ms. Simmons described how the survey was administered. She stated that the district partnered with Panorama Education to administer a nationally normed survey. Ms. Simmons outlined key findings and how the district would use the data in supporting the FY23 District Priorities. Ms. Simmons summarized next steps. #### Superintendent's Comments

Superintendent Gutekanst shared a recent experience at Sunita L. Williams Elementary School involving Physical Education and Wellness teacher Rob Tatro, Dr. Karen Richardson, Professor of Movement Arts at Bridgewater State University, and Dr. Naoki Suzuki, Professor of Physical Education and Teacher Development at the University of Tokyo. He stated that the three of them have been collaborating using a tool called class cloud. He stated that this tool connects Mr. Tatro's students with students in Tokyo, sharing lessons and ideas about movement and physical education, and wellness. He stated that the heart of this is the international collaboration made feasible by technology. Superintendent Gutekanst stated that it is great to see a tool used like that to bring kids together in learning.

Dr. Gutekanst shared with the School Committee that Bids have been received. He stated that the total additional costs would be \$2.7M which includes contingency. Dr. Gutekanst stated that the Permanent Public Building Committee (PPBC) has met and voted to award the contract pending the outcome of Town Meeting. He stated that the Finance Committee has met and voted to support the additional funding. He stated that overall, he is prepared to present this request to Town Meeting. Discussion followed.

## Department of Elementary and Secondary Education Comprehensive District Review Report September 2022

Dr. Gutekanst led the discussion on this item. He stated that on January 24-28, 2022, the Department of Elementary and Secondary Education (DESE) completed a systemwide audit of the Needham Public Schools. He stated that the audit had three main purposes, continuous improvement, consider the effectiveness of systemwide functions using six district standards established by DESE, and promote district reflection on its performance and potential next steps for improvement and growth. Dr. Gutekanst presented a slideshow presentation on the report. 
## Student Growth Percentile








#### GR302 MCAS District and School Growth Distribution



I think teachers of grades 11 and 12 are now seeing/noticing the impact of the 2020-2021 school year on their students' skills and are adjusting their practice so that they can move their students forward.

We have data from the pilot year, but more time is needed to see the full impact across K-5.

This has increased support of students, behavioral interventions/supports, and partnerships with families

Having a coaching model for teachers as well as a support person who could provide tier 2 interventions has been impactful for students and staff.

While the students that utilized this resource found it helpful, especially during remote week or when falling behind. Some students were reluctant to learn from a video and we could have collected more specific data on this intervention.

#### District Leaders' Personal Reflections

# Key Takeaways:

- Needham Public Schools examines MCAS data in order to continually improve teaching and learning.
- Similar to other districts around the state, we are in a recovery period in direct response to disrupted learning caused by the global COVID 19 pandemic.
- Chronic absenteeism and reduced access to quality instruction has a significant impact on student achievement.
- In grades 3-8, the percentage of students meeting and exceeding expectation is lower that 2019.
   However, our student growth percentile is higher.
- In grade 10, our percentage of students meeting and exceeding expectations in ELA is near pre-pandemic levels. Though math student growth percentiles continue to average above the state level, math growth appears to be slowing.
- 6. At least **50 interventions** have been implemented and reviewed in the last 2.5 years to support recovery efforts.

# Ongoing Steps:

- Introducing data inquiry cycles and data analysis at district leadership meetings
- Reviewing **interventions**, i.e. Summer Bridges, for impact
- 3. Partnering with Cornelius Minor on sustaining classroom conditions that are equitable
- 4. Allocating and aligning the **budget** to the strategic plan and our focus on equity
- 5. District action steps and school **improvement plans** address marginalized student populations
- 6. Listening and **learning** through Dr. Carmen Williams' entry plan process.





To ACCEPT Board of Directors,

Per the Collaborative Agreement Governance, the following is the FY 23 Quarterly updates on the programs and services provided by the Collaborative for July - September 2022.

FY 23 began with welcoming staff and 94 students for the Extended School Year Program. Professional Development was offered on August 30th and 31st for all staff with doors open to welcome students on September 1, 2022. Our student enrollment on opening day was 124 students with our end of month number at 128 students (119 placements and 9 extended evaluations). This is an increase of 34 students during this quarter. The minimum target for the number of students is 127 students.

There are currently 13 Home Based Services cases being served by 7 BCBA supervisors and 8 direct therapists. In addition to home services for students and parent training, ACCEPT is conducting 4 functional behavioral assessments within homes.

The Transportation Department provides out of district transportation for 7 member districts. Currently, we transport 186 students across the state of Massachusetts through the efforts of 62 drivers and 18 monitors.

The Professional Development and School Consultation departments have been providing hybrid and virtual PD opportunities for all educators. The Professional Development has met 75% of this year's targeted revenue with many additional PD opportunities to come. School Consultation has extended contracts for services with 10 school districts. The job alike groups have been increased this year to include a DEI and SEL Directors group. ACCEPT is offering a variety of PD opportunities for low incident teaching staff such as music teachers for November 8th PD day. Additionally, our consultants are also working with districts to conduct program evaluations for specialized district programs and student assessments.

With regard to finances, ACCEPT has invoiced \$2,969,436 for services rendered. \$1,818,882 has been received and is accounted for in our year to date profit and loss with an additional \$1,250,554 in accounts receivable. To date ACCEPT has expended \$2,147,075 presenting ACCEPT with a current net profit of \$822,362 at the end of the first quarter.

The FY23 budget reflects the May 2022 Town Meeting appropriation of \$87,277,798, plus cumulative budget transfers made since the beginning of the fiscal year. (A listing of the budget transfers made during the first quarter is included as Attachment A.) In prior years, the amended budget also included encumbrances rolled forward from the preceding fiscal year. Since FY05, however, these 'prior-year encumbrances' have been segregated to a separate fund within the Town's accounting system, and are not included in the operating budget. A summary of prior-year encumbrance activity is presented below.

As of September 30, the regular School Operating Budget was 11.5% expended, compared to an overall (weighted) target ratio of 11.7%. A total of 11.2% of the appropriated salary budget has been spent to date, reflecting the fact that teachers and administrators, who comprise the largest groups of employees within the District, have received approximately 8.3% and 25.0% of their yearly pay, respectively. The purchase of service and expense accounts are 13.6% expended, compared to a 12.7% target rate, reflecting the fact that school supplies typically are purchased in advance, while services are paid on a delayed basis, approximately one month after being rendered. Circuit Breaker reimbursements have not yet been applied to special education expenditures.

In addition, funds have been encumbered to pay \$62.45 million in salaries and wages during the rest of this fiscal year, as well as to purchase an additional \$7.55 million in goods, services and capital equipment. (An encumbrance is a 'reservation' of budget funds, which have been set aside to pay anticipated expenditures.) When these additional encumbrances are added to year-to-date expenditures, the overall 'expenditure' rate climbs to 91.7% of total budgeted funds. Additional expenditures will be encumbered on an ongoing basis throughout the school year.

Currently, the Business Office is developing detailed projections of anticipated expenditures and revolving fund deficits, and will present more information on the evolving budget situation in the upcoming weeks and months.

Attachment B presents year-to-date expenditure, encumbrance and target rate information for all school operating budget line items.

Prior year encumbrances totaling \$1,451,092 were carried forward from FY22 to FY23. As of September 30, \$504,696 (34.8%) had been used to pay prior year invoices received after July 1. Additional encumbrances totaling \$127,332 (8.8%) were liquidated because they were no longer needed. The balance – encumbrances totaling \$127,332 (56.4%) – remain open to pay pending invoices. The School Accounting office is in the process of reviewing the remaining open encumbrances and collecting invoices.

### Grants, Donations & Revolving Funds:

Needham also receives revenue from state, federal and local granting agencies, donors and school-sponsored fee-based programs. A summary of first quarter balances is presented below:

To date, Needham has been awarded \$3.3 million in new FY23 federal, state and local grants. Since FY19, the federal grant period has been adjusted to end on June 30, however DESE will allow districts to continue spending past the deadline for an additional 12 months in order to provide for special education needs and professional development/curriculum planning evens for teachers.

The Needham Public Schools also operates donation and revolving accounts. Donation accounts contain funds given by PTC's, other organizations and private individuals to support instruction and co-curricular activities, such as athletics. As of September 30, \$5,574 in donated funds had been received. Additionally, the School Department receives in-kind donations of goods and services, the value of which is not reflected in the totals above. Since donation accounts are rolling accounts, any unexpended funds at year-end will roll forward to FY23 as available revenue.

Finally, the School Department operates several fee-based programs. These programs, which include Nutrition Services, Athletics and Community Education, are mostly self-sustaining; program expenses are paid from fees charged to program participants. (The Operating Budget funds portions of the athletics, transportation and preschool program expenses.) Since balances in these accounts also roll forward from year to year, these accounts are called "revolving funds." By September 30, \$720,339 in user fees had been collected to support these programs. Unexpended funds at year's end will roll forward to FY23 as available revenue. The \$1,237,887 negative balance reflected in the above chart for the revolving funds reflects the fact that salaries and expenses are fully encumbered for the entire year, while revenues reflect only year-to-date receipts.

A report summarizing FY23 first quarter expenditure activity in school grant, donation and revolving accounts is presented as Attachment C.

## Trust & Agency Accounts:

The School Department also has funds in several investment accounts that are held in trust for a specific purpose, or on behalf of another party. The Town's Trust Fund Commissioners are responsible for investing and managing the trust funds, which consist of scholarships for students and funds to support operations. The School Department also acts as fiscal agent for monies that students collect in support of their own activities. These student activity funds do not belong to the School Department, but rather belong to the students. Trust and agency accounts exist outside of the regular School Operating Budget in separate, specialized accounts. A summary of the first quarter balances in these accounts, is presented below:

The current book value of the trust and agency funds is \$5.4 million. Since the beginning of the fiscal year, donors have contributed \$19,393 to support scholarship activity at Needham High School. The current balance in the student activity accounts is \$449,948, which reflects current year fundraising of \$26,171 and expenditures to date of \$1,582.

A report summarizing FY23 first quarter expenditure activity in the school trust and agency accounts is presented as Attachment D.

## School Cash Capital Funds:

Expenditure activity in school cash capital accounts is presented in Attachment E. The chart includes only those projects for which funds have been appropriated to the School Committee. Construction projects are managed by the Permanent Public Building Committee (PPBC), facility maintenance projects are managed by the Public Facilities Department and athletic facility projects are overseen by the Parks and Recreation Department. These cash capital accounts remain open until completely expended.
