The person asked for Superintendent Gutekanst to be excluded from the meeting and then asked that the School Committee nullify the Superintendent's legislation on the grounds of non- compliance or terminate the Superintendent's employment contract with the town on the grounds of gross misconduct and unethical misconduct.

He suggested that the Massachusetts Department of Education conduct a review of possible curriculum violations and possible licensure violations arising out of the Superintendent's classroom practices.

#### **Superintendent Comments**

Recently, the Superintendent served as a judge for the "Poetry Out Loud" contest at Needham High School. 10 individuals recited and acted out 2 poems that they had memorized; the winner of this contest will go on to the state finals. He congratulated Isabella Barbaria, Mihret Hopkin and the winner, Ben Fogler, who will move on to the State finals.

#### Agenda Item: Discussion

#### Portrait of a Needham Graduate Presentation: Elementary Social Studies

Social Studies K-8 Chair, Brooke Kessel, along with Eliot Teacher, Brittani LaPorte and 4<sup>th</sup> Grade Student, Lauren Valerio presented. Brooke explained that Investigating History is a new Social Studies program designed by DESE in collaboration with Primary Source and Educurious. In 2022-2023, Grade 5 was prioritized with a pilot at Broadmeadow and Newman. In 2023-2024, Grade 5 was implemented districtwide; Broadmeadow and Eliot were pilots in Grade 3 and 4.

Needham is one of 38 districts in Massachusetts that is implementing Investigating History in 5<sup>th</sup> grade this year. This program teaches students to become creative thinkers and problem solvers. Teachers are excited for this new curriculum; because prior to Investigating History, there was no Social Studies program in the district. Teachers now feel they have the tools that they need to instruct every student.

#### Agenda Item: Discussion

#### Athletic Program Report

Athletic Director, Ryan Madden and Assistant Athletic Director, Richkaard Verrier presented. Ryan remarked what drew he and Rich to the Needham Athletic program is the success both on and off the field and court, the leadership among the students and coaches, the sportsmanship and the community feel – they have a great foundation and they are looking to build on that. Their mantra for this year is "For the Students, By the Students."

They have created S.A.L.T. – "Student Athlete Leadership Team". This team has collaborated with the Graphic Design Club to create a new Booster's Sticker for the Fall, they created new logos for their conference, a branding book for more consistency. This team has created the questions for the end of the season survey for the athletes; they are also working to create feedback for parents and guardians. Ryan mentioned that he would like to grow the S.A.L.T. team to about 25 athletes across all sports.

Athletic Program Report Ryan said some challenging points are lack of officials, lack of bus drivers and lack of facilities because of the large number of programs that Needham has. Chair Longo Carter said that the focus we have in this community when it comes to sports is having kids have a very positive experience being part of a team.

#### Agenda Item: Discussion

#### 2024-2025 Middle School and High School Programs of Studies

Mr. Sicotte, Dr. Bibbo and Dr. Downey presented. Dr. Downey shared at High Rock, English Language students can take an additional EL class in place of an enrichment. This has never been identified and Dr. Downey wanted to be transparent in this opportunity for the students.

Dr. Bibbo said that 8<sup>th</sup> grade students in their second trimester can choose a different elective within the ELA course; this was a pilot program but is now a part of the permanent program. Other changes are that American Sign Language and La Francophonie is now becoming part of the permanent programming. Chinese Culture is no longer offered as the Mandarin program is growing.

Mr. Sicotte outlined some additions within the high school curriculum – Young American Literature, Accelerated Jazz, Jazz Lab, Advanced Acting Study and Probability and Games. He also mentioned they are providing adjustments within some 9IP courses; co-seating Honors and Accelerated in the same class. Mr. Sicotte explained that some students were resistant to 9IP as they wanted Accelerated classes.

A question was asked about Special Education students that would like to take a full year Performing Arts elective (chorus or band); this is not possible as their schedules only allow for a semester elective due to the Physical Education requirement. Mr. Sicotte explained that they are trying to think of creative solutions, as schools in surrounding towns are trying to solve this issue as well.

A committee member asked how the middle school math program is now compared to a traditional math program that was taught years ago. Dr. Downey explained that they are asking students to think and understand conceptually as well as being fluent in math. She said that this math is more project based and conceptual with problems that are based on real life. Dr. Bibbo remarked that they are focusing on station work and interdisciplinary connections. Middle school is making math engaging and exciting; the after school help classrooms are jam packed with students. Middle School and High School Programs of Studies

#### **GLOSSARY:**

Authentic Assessments - Assessments that replicate real-world scenarios to provide relevant opportunities to demonstrate and apply learning in meaningful ways.

**CASEL Frameworks** - A DESE-endorsed program that focuses on five core SEL competencies; they are: self-awareness, self-management, social awareness, relationship skills, and responsible decision-making.

**Culture and Climate Committee (CCC)** - An NHS committee with representatives from all departments, co-chaired by a teacher and an administrator, focused on the social and academic environment of the building, with a particular emphasis on issues of equity.

**Culturally Responsive Teaching (CRT)** - Gary R. Howard's definition of culturally responsive teaching is, "*our capacity as teachers to know and connect with the actual lived experience, personhood, and learning modalities of the students who are in our classroom*" (We Can't Teach What We Don't Know, 131). His three-parts center on Know Yourself, Know Your Students, and Know Your Practice, and we draw heavily on his writing to drive our work within classrooms and offices.

**High School Leadership Team (HSLT)** - The NHS leadership group consisting of all NPS administrators with responsibilities within NHS, including the principal and assistant principals, building-based department chairs, and district-wide department directors, focused on establishing the vision and direction for NHS, as well as, the finer policies and practices that help it run efficiently and effectively.

**Interdisciplinary Learning Skills** - The set of skills that are important in all discipline areas (such as collaboration, problem solving, resiliency, creativity, etc.)

**Interdisciplinary Learning Team (ILT)** - An NHS committee with representatives from all departments, co-chaired by a teacher and an administrator, focused on interdisciplinary skills and learning at NHS, as well as, integrative learning opportunities that cross and connect departments.

**NEASC Committee** - An NHS committee with representatives from all departments, co-chaired by a teacher and an administrator, focused on our ongoing accreditation with the New England Association of Schools and Colleges (NEASC) and the planning and communication required to maintain it.

**Project-Based Assessments** - Assessments that are cumulative projects that allow students to demonstrate and apply a broad set of skills and knowledge in meaningful ways that are collaborative and based on real-world scenarios.

**SAMR Model** - A framework created by Dr. Ruben Puentedura that categorizes different degrees of classroom technology integration; the categories are: Substitution, Augmentation, Modification, and Redefinition.

**Social-Emotional Learning (SEL)** - Understanding and managing our emotions and responsible decision-making, as well as, how we interact and interrelate with those around us.

**Social-Emotional Learning Committee** - An NHS committee with representatives from all departments, co-chaired by a teacher and an administrator, focused on both the understanding of SEL skills and their incorporation into all social and academic aspects of NHS.

**Technology and Innovation Committee** - An NHS committee with representatives from all departments, co-chaired by a teacher and an administrator, focused on the effective incorporation of technology into instruction and advising on our use of and deployment of technology throughout the building.


**Universal Design for Learning (UDL)** - is a way of approaching instruction that is research-based and focuses on flexible learning environments and learning spaces that provide accommodations for all individual learning differences and needs.

**X-block** - Time within the NHS schedule for students - particularly struggling students - to get academic or social-emotional help from their teachers, counselors, or administrators.

The testing data in the Performance Report demonstrates our students' continued high performance on standardized tests in comparison to national and state-wide performances. In some areas, such as with the ACT, our students' performance is at or among the highest it has been over the last five years, and our participation in SAT tests have risen back up from a low in 2021, while our students continue to gain qualifying scores on AP tests at about 90%, all positive indicators of the strong academic experience NHS provides, as well as our students' resiliency and ability to overcome some of the pandemic challenges.

In the midst of these challenges and impacts, it is more important than ever to see the whole student in front of us. Performance on a test is one small indication of how a student achieves. This report attempts to capture a sense of the many varied ways the students of NHS continue to demonstrate their growth in all areas of the Portrait of a Needham Graduate. They are engaged in exciting and empowering work, improving the world around them, and partnering with a wide range of people and groups to excel in a multitude of ways. I hope you enjoy the glimpse into the many achievements of the students of Needham High School.

The attached report summarizes the results for the SAT I (Evidenced Based Reading and Writing, Mathematics), ACT, and AP (Advanced Placement) examinations.

Testing restrictions and limitations, prominent during the pandemic, have been lifted for the past two testing cycles. Nationally, SAT and ACT testers are on the rise while also reflecting the more comprehensive test optional policies now in place at most colleges. The College Board and ACT provide summary data for all test takers of a graduating year, regardless of the year the last SAT and/or ACT for a given student was taken. SAT I data reported by the Department of Elementary and Secondary Education (DESE), for test takers in the year 2023, will be used in this report for comparison with other towns.

This is the eighth year we have included ACT performance data.

AP results pertain only to the testing which took place in spring 2023, and include members of the class of 2023 as well as other students.

Highlighted below are several summary items.

#### SAT I - Critical Reading/Evidenced Based Reading and Writing and Math Tests

The College Board changed its reporting of SAT data and we have adjusted our reporting accordingly. For the Class of 2023 we can break down the scores by range for the 263 test takers who took the test at least once during high school (if taken more than once only the most recent test result included).

The College Board did provide mean SAT I data for Massachusetts (EBRW – 560; Math – 551) and the Total Group (EBRW – 520; Math – 508). DESE reports the total test takers for a given year (not by graduating class); the 379 test takers for the 22-23 testing cycle at Needham High reported SAT I averages as EBRW – 626 and Math – 632 (from DESE website).

#### SUBJECT TESTS (SAT II)

The College Board has discontinued the SAT Subject Tests, so scores and comparison data are no longer included in this report.

#### ACT TEST

The number of ACT test takers from Needham High had been rising steadily until 2017, since then the total test takers has fluctuated. For the graduating class of 2023, twenty percent (20.0%) took at least one ACT test. This is a decrease in total test takers from the year prior and lowest total 5 years. The lower numbers are consistent with National and MA trends.

Included in the following chart is the ACT section and composite averages over the past five years for Needham High test takers. The Class of 2023 test takers achieved the highest ACT scores across all sections (with the exception of English in 2021) in the past 5 years.

#### ADVANCED PLACEMENT (AP) EXAMINATIONS

Four hundred sixty-five (465) students took nine hundred sixty-one (961) AP tests. Ninety percent (89.8%) of the scores were 3 or better. Seventy percent (69.6%) of the scores were 4's and 5's. A more detailed presentation of these data is available in the report that follows.





- Members volunteered to help SPAN deliver positive community norms posters to Needham schools and businesses in September, October, November and December.



### Technology Resources Purpose:

Access to network resources, electronic communications, the Internet, database systems, devices and other information technology (IT) resources is essential to the mission of the Needham Public Schools (NPS). The purpose of these resources is primarily to develop, deliver, and support quality educational materials in the pursuit of excellence in teaching and learning and to efficiently manage the day-to-day operations of the NPS.

Information Technology will be used in a manner consistent with the educational mission of the Needham Public Schools. The user will exercise good and professional judgment in the use of shared resources, software, intellectual property rights, ownership of information and system security. Professional behavior and communication are expected at all times. All home use of NPS devices and district-provided accounts and resources must adhere to the terms and conditions of acceptable use as outlined in this policy. Use contrary to this policy (IJNDB-1) is unacceptable and prohibited.

Use of any of the schools' IT resources by any user will constitute acceptance of the terms of this policy and of any further amendments. All staff will sign an acknowledgment that they have read the Staff Responsible Use policy. A failure to comply with the acknowledgement provision does not relieve a user of the obligations and responsibilities of the Responsible Use Policy.

#### Privacy:

Employees should have no expectation or guarantee of privacy when using the schools' IT resources whether their use takes place during or outside working hours. All actions including, but not limited to, information stored, accessed, viewed or written are logged and accessible by the Administration. The NPS has the right to monitor, quarantine, backup, move, archive and/or delete, and access all electronic files, local or remote, on systems managed by the district.

All actions performed by employees in regards to the schools' IT resources are legally discoverable and could be subpoenaed by a court of law and are potentially considered to be public records under Massachusetts and federal statute.

#### Data Confidentiality:

Some employees, as part of their jobs, have access to confidential information such as personal data about identifiable individuals. Personally identifiable information remains confidential; employees are expected to use appropriate judgment and caution in communications concerning students and staff. Employees are strictly prohibited from acquiring access to and/or disseminating such confidential information unless access to and/or dissemination is authorized and required by their jobs. Digital information may be subject to federal (FERPA) and state privacy statutes.

Employees are expected to exercise reasonable judgment in the use of private student data and only as part of their employment responsibilities with the Needham Public Schools. This includes the use of electronic student data that may be transported on devices, computers, drives, and in other ways to and from the workplace. If an employee suspects or believes private student data and records have been lost, stolen, or otherwise compromised, the employee should immediately notify her/his supervisor.

#### Curriculum and Resources:

Resources used to create digital learning experiences as part of an employee's responsibilities with the NPS may be pre-approved and accessible by the appropriate administrator (Department Head, Director, Principal, or other District Administrator) to ensure program consistency, continuity, safety, and liability. Employees must adhere to appropriate copyright laws and guidelines when developing, using, and/or reproducing protected material.

### Email and the Public Records Law:

Email messages concerning official school business are generally considered public record information that is subject to disclosure under the Massachusetts Public Records Law. (M.G.L. Chapter. 66 Section 10: M.G.L., Chapter 4, Section 7(26)).

Documents prepared in anticipation of litigation or to reply to a Freedom of Information Act (FOIA) should not be disclosed without prior approval from the Superintendent.

#### **Professional Communication and Practices:**

Employees should communicate in a professional manner. Communication between and among staff, students, and families should be educationally relevant, including the use of social media.

Supervisors may choose to approve the form and content of work-related communication prior to dissemination.

#### Social Media Use:

Social media encompasses online platforms and technologies that enable users to create, share, and interact with digital content, fostering various forms of communication and community building. Within the Needham Public Schools, this can facilitate engagement among students, parents/caregivers, teachers, and community members, strengthening connections, promoting shared goals, and creating a sense of belonging.

When using communication tools such as social media as part of their professional role and responsibilities, employees of the Needham Public Schools are representing the District. It is the expectation of the District that employees model behaviors that are inclusive and supportive of the Mission and Vision of the Needham Public Schools.

Employees are required to adhere to the expectations shared in the NPS Social Media Guidelines. This document is reviewed regularly and updated as needed based on trends, initiatives and needs of the District.

### Social Media Accounts/Sites Representing Needham Public Schools:

All Social Media accounts/sites created for the purpose of sharing information about the District must be first approved by the building Principal and should make clear they are maintained by an NPS staff member and are required to be created, maintained and linked to an active district email account.

Employees who maintain the social media accounts/sites should have no expectation of privacy in regards to the content, private messaging or posts produced or associated with the account/site. Transparency and accountability for all content, private messaging and posts enables efficient collaboration, ensures alignment with the District's policies and fosters public trust. This includes, but is not limited to, scheduled posts, direct messages, comments on public posts, shared materials, and any drafts or archived data associated with the account/site.

Content regarding students (including personal identifiable information) shall not be posted on any Needham Public Schools website or social media account/site unless they are approved for photo release.

The Superintendent and their designees have the right to monitor accounts or sites created using NPS accounts, and employees who maintain the accounts/sites will be required to furnish administrative passwords upon request.

#### **Prohibited Uses:**

Each employee is responsible for their actions involving information technology and their electronic files, passwords and accounts. Examples of prohibited use of school IT include, but are not limited to, the following:

1. Any use that violates any federal, state or local law or regulation, including copyright laws, or violates a School Committee policy;

2. Any use to harass, discriminate, threaten, defame, demean or intimidate;

3. Any use that involves material or language that is vulgar, profane, obscene, fraudulent, offensive, sexually explicit or sexually suggestive;

4. Any use for private financial gain, advertising, online gambling or solicitation purposes;

5. Conducting private business that is not incidental in nature;

6. Fundraising for any non-school sponsored purpose, whether non-profit or for-profit;

7. Downloading, using or copying software in violation of a license agreement or copyright;

8. Infringing on intellectual property rights;

9. Connecting any device not owned and managed by the NPS to the internal school network (other than the "Open" wireless access to the Internet) without permission from the technology administrator;

10. Obtaining confidential information about students and/or their families for non-school related activities or sharing confidential information about students or employees for non-school related activities;

11. Sending mass electronic mailings or chain letters, excessive printing, spending excessive amounts of time on the Internet that interferes with the employee's official duties and responsibilities; or otherwise creating unnecessary network traffic;

12. Revealing one's password to anyone else, using another's password, or pretending to be someone else when sending information over the school network;

13. Forgery or attempted forgery;

14. Gaining or attempting to gain unauthorized access to any device or network [i.e. hacking];

15. Any misuse or disruption of school IT, including intentional physical misuse or damage, or any breach or attempt to breach the security features of school IT;

16. Any communication that represents personal views as those of the schools or that could be interpreted as such;

17. Any communication that violates generally accepted rules of electronic mail or device etiquette and/or professional conduct;

18. Posting pictures or audio, or identifiable information of students, administration, faculty, and the parents of students that is not educationally relevant;

19. Failure to report a breach of school IT security to the employee's supervisor;

- 20. Using District resources for union business that is not incidental in nature;
- 21. Any other misuse identified by District administration.

Employees who have a question or need further clarification about these prohibitions should seek guidance from their building principal or supervisor.

#### Responsibility for Laptops/Mobile Devices Issued to Faculty and Staff:

An employee who has been issued a laptop or other mobile device is responsible for the equipment at all times in school and outside of school. Upon the conclusion of an individual's employment with the Needham Public Schools, the employee will return all school issued technology and technology devices.

#### Responsibility for Unauthorized Charges, Costs or Illegal Uses:

NPS assumes no responsibility for any unauthorized charges made by employees, including but not limited to credit card purchases, subscriptions, long distance telephone charges, equipment and line costs, or for any illegal use of its devices, such as copyright violations.

#### Disclaimer on Liability:

NPS makes no warranties of any kind, either expressed or implied, that the functions or the services provided by or through its network will be error-free or without defect. The District will not be responsible for any damages users may suffer, including but not limited to, loss of data or interruptions of service, or personal, physical, psychological, or monetary damages. Users are responsible for backing up their own data. The District will not be responsible for unauthorized financial obligations arising through the employee use of digital resources.

#### Needham Public Schools Staff Social Media Guidelines

From engaging conversations to sharing valuable resources, the Needham Public Schools community benefits from authentic connections made through social media. These platforms allow us to share information, learn together, inspire one another, and even extend the classroom experience beyond the walls of our schools. However, while social media can be a fun and enriching tool, it's important to remember that in the online world, the lines between personal and professional, public and private, can sometimes blur. To help navigate this digital landscape responsibly and represent our school community with pride, we've created these social media guidelines for you to follow. Let's work together to harness the power of social media for good, fostering a safe, positive, and enriching online environment for all.

#### What is Social Media?

Social media encompasses online platforms and technologies that enable users to create, share, and interact with digital content, fostering various forms of communication and community building. These platforms include, but are certainly not limited to, Facebook, Instagram, X, and Threads.

#### Setting up Social Media

Assistance in setting up social media accounts and their settings can be obtained from your building Technology Integration Specialist. Remember to review the Staff Responsible Use Policy (JJNDB) first.

#### **Don't Tell Secrets**

It's perfectly acceptable to talk about your work and have a dialog with the community, but it's not okay to publish confidential information. Confidential information includes things such as student information, grades, or any other confidential information that would identify individuals. We must protect and respect the privacy of our students, staff, parents, and school community.

#### Protect Your Own Privacy

Privacy settings on social media platforms should be set to allow anyone to see profile information similar to what would be on the Needham Public Schools website. Privacy settings that might allow others to post information or see information that is personal should be set to limit access. Be mindful of posting information that you would not want the public to see.

#### **Be Transparent**

We believe in being transparent online. Use your real name, be clear who you are, and identify that you work for the Needham Public Schools. Do not post anonymously, using pseudonyms or false screen names. Do not write anything that is dishonest, untrue, or misleading. What you publish will be around for a long time, so consider the content carefully and also be cautious about disclosing personal details.

#### Be the first to respond to your own mistakes

If you make an error, be up front about your mistake and correct it quickly. If you choose to modify an earlier post, make it clear that you have done so. If someone accuses you of posting something improper (such as their copyrighted material or a defamatory comment about them), handle it professionally and reach out to your Principal for support.

#### Use your time wisely

It's easy to burn time using Social Media. Make sure that the time you spend interacting on social media platforms, particularly during the work day, is productive, enriching, and supportive of your professional responsibilities.

#### What is Personally Identifiable Information?

Think of your personal identifiable information (PII) as anything that could reveal who you are. This includes your name, address, social security number, phone number, email, and even seemingly less obvious things like your birthday and zip code. It's also anything that lets someone contact you directly, like your home phone number or email address.

#### **Use Good Judgment**

Respect and protect your audience and partners, the public in general, and Needham Public School's staff and community. They reflect a diverse set of customs, values and points of view. Don't be afraid to be yourself, but do so respectfully. This includes not only the obvious (no ethnic slurs, offensive comments, defamatory comments, personal insults, obscenity, etc.) but also proper consideration of privacy. Remember, when you are posting from a school-approved Social Media account, you are representing the Needham Public Schools.

#### Photography on Social Media

It's important to remember that you can't share images/likenesses of students on social media unless they are approved for photo release. Check in with your Main Office if you have questions about this. Additionally, be courteous of your colleagues - ask for permission before posting a photo of them.

#### **Quality matters**

Use a spell-checker. If you're not design-oriented, ask someone who is to review your social media presence, and take their advice on how to improve it. The speed of being able to publish your thoughts is both a great feature and a great downfall of social media. The time to edit or reflect must be self-imposed. If in doubt over a post, or if something does not feel right, either let it sit and look at it again before publishing it, or ask someone else to look at it first.

#### Enforcement

It is expected that all members of the Needham Public School community use social media platforms in a way that is consistent with our educational mission and policies. Should a staff or student deliberately attempt to violate these guidelines or the District's Responsible Use Policy, Needham Public Schools may restrict, suspend, or terminate access to Needham Public School's social media channels. Policy violations may also be subject to additional disciplinary action.

#### **Respect Copyright Laws**

It is critical that you show proper respect for the laws governing copyright and fair use or fair dealing of copyrighted material owned by others. You should never quote more than short excerpts of someone else's work, and always attribute such work to the original author/source. It is good general practice to link to others' work rather than reproduce it.



It is the responsibility of the Superintendent to specify the required actions and design the detailed arrangements under which the schools will be operated. Those actions and arrangements shall constitute the administrative rules which govern the schools. The regulations must be consistent with existing laws and with the policies which have been adopted by the School Committee.

The School Committee reserves the right to review administrative rules at its discretion. The Committee likewise reserves the right to revise or veto such rules, particularly if they are deemed to be inconsistent with adopted School Committee policies or existing laws.

The Administration may request that the School Committee review administrative rules in advance of their issuance, especially in case where strong community attitudes or possible staff/student reaction make it advisable for the Committee's advance approval or endorsement by consensus.

The Superintendent shall be responsible for assuring full and complete dissemination of administrative rules to all employees of the Needham Public Schools who are charged with implementation and execution of such rules, as well as to all staff members, students, parents, and others who may be impacted by such rules.

Regular attendance at school and at all classes is essential to effective implementation of the educational process. While state law requires attendance at school by pupils within certain minimum and maximum ages, it is the policy of the Needham Public Schools to require <u>all</u> pupils to attend school on a regular basis in order to obtain full credit and to benefit to the fullest extent possible from the educational programs of the schools.

The principal has the authority to excuse pupils for absence from school due to illness and other good cause in accordance with the school's attendance procedures. In addition to complying with attendance procedures, pupils must make up work missed due to absence in accordance with established school requirements.

Statement: The Needham School Committee is cognizant of the fact that certain holy days occur during the school year. In order to be fair to all students, it hereby adopts the following policy:

- 1. Excused absence will be allowed on major religious days to enable students to participate in their religious activities. The exercise of conscience is a personal matter and should not be a matter of public discussion.
- 2. Every pupil who is absent for a legitimate reason, including absence for religious reasons, is allowed to make up, within a reasonable time period, the work that has been covered and the assignments made during his or her absence.
- 3. Reports or special projects which are due on one of the major religious days are to be submitted to the teacher at the first class meeting following the pupil's return to school, with no penalty for late filing.
- 4. Teachers are expected to exercise sound judgment in carrying out work when some students may be absent because of a religious holiday. Provision should be made for students who are absent to get assignments that might be necessary ahead of time and to have class work reviewed by the teacher. In no situation should a child be made uncomfortable because he or she chooses to exercise his or her religious convictions.

- 5. No test or quiz of any kind shall be administered in the Needham Public Schools on the second day of Rosh Hashanah.
  - 5.1 Although teachers may administer tests and hold customary classroom activities on other religious holidays, teachers should make every effort to avoid planning classroom activities or giving assignments that might prevent a student from being able to participate fully in their religious observances. Because many observances involve family activities, students should not be expected to complete homework, study for tests, or do other school work during their absence.
  - 5.2 Teachers should provide adequate time for students to make up work and take tests at a mutually convenient time.
- 6. Needham Public Schools will make every effort to schedule no special events the night before, during or after school on major religious days. Needham Public Schools will encourage consideration of its policy in inter-league sports scheduling.
- 7. Each teacher should note major religious holidays on his or her calendar so that this policy can be implemented.
